# Boarding Agreement

1. Mr./Ms. \_\_\_\_\_ (the Owner) has filled out the attached Boarding Arrival Form ("Arrival Form") and agrees that he/she is legally responsible for the following PET(s):

Guest (Dog) 1	Guest 2	Guest 3	Guest 4	Guest 5

The Owner agrees that such legal responsibility shall apply regardless of the true nature of the relationship between the Owner and the PET(s) named above and on the Arrival Form, including but not limited to, the Owner and PET(s) that for all other legal purposes outside of this agreement, may be owned by a third party.

2. The Owner agrees to pay the rate(s) established on the Arrival Form for boarding their PET(s).

3. The Owner agrees to pay all costs and charges for special services requested, all Veterinary or transportation costs, to include all serious damages that the PET(s) may do to persons, property or other PETS and any other costs related to the PET(s).

4. The Owner further agrees that the PET(s) shall not be removed from DOLITTLES until all charges are paid in full to DOLITTLES by the Owner.

5. By executing this agreement, the Owner represents and warrants that the information on the Arrival Form is true and correct. The Owner agrees to release and hold harmless Laura Dash, DOLITTLE's and all its employees or representatives from any liability caused by any inaccurate information listed on the Arrival Form about the PET(s), including but not limited to, costs associated with lawsuits and attorney's fees. The Owner agrees that in boarding the listed PET(s) with DOLITTLES, that DOLITTLES has relied on *the Owner's* representations that the PET(s) is/are in good health and has not harmed or shown aggressive or threatening behavior towards any person.

6. DOLITTLES shall exercise reasonable, professional care during the custody of the PET(s) by DOLITTLES. The Owner agrees that DOLITTLES and their staff will not be liable for any problems that develop through the reasonable care and precautions that are followed by DOLITTLES. In addition, the Owner hereby agrees to release and hold harmless Laura Dash, DOLITTLE's and all its employees or representatives from any liability of any kind whatsoever arising from the PET(s) stay at DOLITTLES, to include the contracting of bacterial or viral issues or diseases while in the custody of DOLITTLES.. It is expressly agreed by the Owner that any form of liability by DOLITTLES to the Owner for the PET(s) shall not exceed the lesser of either the current chattel value of the PET(s) of the same species or the sum of \$100 per PET.

7. The Owner specifically represents that the PET(s) has/have been examined by a Veterinarian and is free of Rabies, Parvo, Distemper or any contagious illnesses. Further, The Owner represents that the PET(s) is/are not aggressive with people. In the event of illness or injury to the PET(s), DOLITTLES shall be granted permission by the Owner to provide/secure reasonable, professional care and treatment for the PET(s) within DOLITTLES discretion.

8. All charges incurred by The Owner shall be payable:
- a. Upon pick-up of the PET(s) for short stays (up to 2 weeks).
  - b. For longer weekly or monthly stays, the Owner will be charged in weekly increments at the rate listed in the Arrival Form, on the FIRST day of the new week incoming, the final week charged upon Pick-up. DOLITTLES shall have, and is hereby granted, a lien on the PET(s) for any and all unpaid charges resulting from the Pet(s) stay at DOLITTLES. The Owner hereby agrees that in the event boarding charges are not paid when due in accordance with this Agreement, DOLITTLES may automatically exercise its lien right to pursue litigation Seven (7) days after the Owner's failure to pay any amounts due.

**ABANDONMENT CLAUSE:**

PET(s) not picked up by the Owner after seven (7) days past the agreed pick-up date shall be deemed "Abandoned." California law (California Penal Code Sec. 597S ) provides that animal abandonment is "...*anyone intentionally, knowingly or recklessly or with criminal negligence leaving a domesticated animal at a location without providing for that animal's continued care.*"

For the avoidance of doubt, fees shall continue to accrue to the Owner for the 7 days after the due date, at which point Abandonment by the owner will be established and DOLITTLES will enforce its lien rights herein. At DOLITTLES' discretion, DOLITTLES may, but is not obligated to, "ReHome" the PET(s) for any and all unpaid charges or abandonment, at private or public sale in the sole discretion of DOLITTLES and once in this process, the Owner specifically waives all statutory or legal rights to the contrary.

9. In the event that the Owner has abandoned the Pet(s) and not paid all fees and costs herein, DOLITTLES shall have the right to exercise any legal remedy available including the filing of suit if a sale shall not secure a price adequate to pay such costs of board or other delinquent charges, plus costs of sale. The Owner agrees that in the case of abandonment and/or litigation, service to the address listed on the Arrival Form by certified mail shall be used for all legal purposes and constitute proper service unless the Owner provides a different address in writing to DOLITTLES.

10. This instrument (using information from the Owner's Arrival Form) contains the entire Agreement between the parties and any changes must be in writing and executed by the parties. All terms and conditions of this Agreement shall be binding on the Owner's heirs and administrators.

11. Any controversy or claim (except those that may be settled in small claims court) arising out of or relating to this Agreement, or the result of any claim of controversy involving the alleged negligence by any party to this Agreement, shall be settled by arbitration in accordance with rules of the American Arbitration Association and judgment upon the award rendered by an arbitrator entered in any Court having jurisdiction thereof.
